POOL REGULATIONS

1. General information

The swimming pool is category A2 ~pool for collective use~ and is composed of two pools with different heights, the first is 1.20m high, the second 1.40.

The use of the swimming pool is strictly reserved for the guests of the B&B. Pursuant to art. 4, paragraph 5, letter d of the Molise regional law of 17 April 2012, no. 1, the figure of a lifeguard is not provided for.

Access is prohibited to minors under the age of 14 unless accompanied by an adult, access is also permitted to minors under the age of 18 provided that an adult assumes full responsibility for them.

Guests use the swimming pool under their own exclusive responsibility.

2. Opening hours

Access to the pool is permitted only during the established opening hours. Opening hours are from 09:00A.M to 08:00PM.

Use of the pool outside of the indicated hours is prohibited for safety reasons, as ordinary maintenance work is being carried out.

Opening hours may be subject to change in the event of bad weather conditions or other needs that may arise.

In accordance with daily cleaning and maintenance needs, the facility is available to bring forward/postpone opening/closing times to accommodate any guest requests.

3. Access to the swimming pool

The pool is only accessible via the main stairs leading to the garden.

During closing hours as well as in other different situations in which it is necessary to close access to the pool, a cordon will be placed on the main stairs leading to the garden, with an information sign.

It is strictly forbidden to climb over or move the cordon or take alternative routes in order to still use the pool.

4. Use of surrounding furniture

The area surrounding the pool is equipped with furnishings such as sun loungers and umbrellas.

It is forbidden to lie down or sit on sun loungers or other furnishings before having placed a beach towel that covers the entire surface.

We recommend the utmost care and diligence in using the furnishings, as well as reporting any defects or problems found.

5. Entrance

Access to the pool is only possible via the stairs inside.

Access to the pool is permitted only after:

- having completed a shower;
- rinsing your feet;
- wearing a swimming cap and swimsuit.

Access to the pool is prohibited:

- when you have wounds, abrasions or skin changes of an infectious nature;
- if you have gastrointestinal problems;
- with underwear;
- under the influence of alcohol or drugs;
- to dogs and animals in general.

It is recommended not to use the pool before 3 hours have passed since your last meal.

6. Prohibited behaviors

A series of behaviors are mentioned that are strictly prohibited during the use of the pool:

- A. Consuming food or drinks inside the pool;
- B. Diving into the water by running or by being pushed by another person;
- C. Introducing objects not made available by the facility into the pool;
- D. Yelling or otherwise behaving in a way that could disturb other guests;
- E. Urinating or spitting in the water.

7. End of use of swimming pool

After swimming, it is advisable to rinse off under the shower to remove chlorine from the skin.

Before leaving the pool area, it is necessary to collect personal effects and beach towels.

8. Maximum user capacity

For safety reasons, the maximum capacity of the pool is set at 16 people at a time.

Please note that the capacity of the pool exceeds the maximum number of guests of the B&B, therefore the set limit of 16 people will never be reached.

9. Toilets

The swimming pool is reserved for the guests of the B&B, therefore the reference toilets for each guest are those inside the rented room.

10. Emergencies or dangerous situations

In the event of accidents requiring medical attention, it is necessary to immediately call the emergency number of the emergency room, i.e. 118. Only after having contacted the medical emergency services, please notify the pool manager at +39 3661991729 or, in case of unavailability, +39 3387330290.

To report certain or potential dangerous situations, please contact the pool manager at the contact details above.

11. Responsibility profiles

Guests use the pool at their own risk. The management declines all responsibility for any accidents or damage to people or things, whether in the case of proper or improper use.

The management also assumes no responsibility for any objects left in the pool area, even if not left unattended.

12. Acceptance and publicity of the regulation

Full acceptance of the following rules is an essential condition for accessing the pool service.

The rules are publicized by publication on the property's website ~www.relaiscasalecorvo.com~, by displaying them in the rented room, as well as where supported by Booking and similar portals.

Acceptance of the rules and conditions of use of the pool occurs in advance when booking the room and does not require a signature.
